This is in continuation to MoD ID no. 1(1)/D(Acq)/25 dt 25 May 2025 with regard to DAP Review Committee.

2. The broad objectives of the DAP Review are enunciated as under:-

(a) To meet the operational requirements and modernisation of the Armed Forces in a timely manner in order to ensure the security of the Nation.

(b) To align the DAP to GoI policies and initiatives in order to:-

(i) achieve 'Atmanirbharta - Self Reliance' by promoting technology infusion through indigenously designed and developed systems.

(ii) enable 'Make in India' by promoting Defence manufacturing in India through facilitation of JVs, ToT avenues for private sector, encourage FOEMs through alignment of the FDI policy etc and to make

India an international Defence manufacturing and MRO hub.

(iii) promote 'Design & Development', both in the public and private sectors, for the infusion of indigenous technology and design by Startups, Innovators, and Private Defence Industry.

3. In order to achieve the above objectives, the Committee solicits comments of all stakeholders on the following:-

(a) Suggested policy/procedural changes to streamline the acquisition procedure related to issues like categorisation, ease of doing business, conduct of trials, post-Contract management, Fast Track procedure for absorption and procurement of new emerging technologies such as AI in existing and future systems. etc

(b) Changes desired in the language of the DAP to remove ambiguity and inconsistencies, and other aspects for inclusion/deletion to enhance clarity of procedures

(c) Any other issue which needs to be addressed as part of the review.
