NOTICE FOR PUBLIC CONSULTATION

Subject: Amendment of the Mineral (Auction) Rules, 2015 and the Offshore Areas Mineral (Auction) Rules, 2024 for prescribing minimum 2 technically qualified bidders for proceeding with the auction in the first attempt - reg.

The existing provisions of the Mineral (Auction) Rules, 2015 framed under the Mines and Minerals (Development and Regulation) Act, 1957 and the Offshore Areas Mineral (Auction) Rules, 2024 framed under the Offshore Areas Mineral (Development and Regulation) Act, 2002 provide that there should be at least three technically qualified bidders to continue with the auction of mineral blocks after technical qualification stage. In case there is less than three technically qualified bidder, then the first attempt of auction is annulled and State/ Central Government may decide to conduct the second attempt of auction.

- 2. In case of auction of coal blocks by the Ministry of Coal since June, 2020, minimum 2 technically qualified bidders are required for proceeding with the auction in the first attempt. A similar requirement is proposed in case of auction of blocks of other minerals. The proposed step is crucial to improve the success rate of auctions in first attempt which would help in minimizing delays.
- 3. Accordingly, it is proposed to amend the Mineral (Auction) Rules, 2015 and the Offshore Areas Mineral (Auction) Rules, 2024 for prescribing minimum 2 technically qualified bidders for proceeding with the auction in the first attempt. The draft notification for amendment of the above rules is enclosed herewith as Enclosure for comments/ suggestions of the general public, Governments of States and Union Territories, mining industry stake-holders, industry associations, and other persons and entities concerned.
- 4. In view of the above, it is requested that comments/ suggestions on the above issues may be sent **on or before 22.10.2025**.
