G.S.R. ....(E).- In exercise of the powers conferred by sub-section (1), read with clauses (j) and (q) of sub-section (2) of section 52 of the Legal Metrology Act, 2009 (1 of 2010), the Central Government hereby makes the following rules further to amend the Legal Metrology (Packaged Commodities) Rules, 2011, namely:-

1. Short title and commencement. – (1) These rules may be called the Legal Metrology (Packaged Commodities) (Second) Amendment Rules, 2025.

(2) These rules shall come into force on the date of their publication in the official gazette.

2. In the Legal Metrology (Packaged Commodities) Rules, 2011 (hereinafter referred to as the said rules), in rule 6, in sub-rule (10) the following shall be inserted, namely:-

“Provided that every e-commerce entity selling imported products shall provide a searchable and sortable filter for the country of origin, with their product listings.”

सा.का.नि. .... (अ) - केन्द्रीय सरकार, विधिक मापविज्ञान अधिनियम, 2009 (2010 का 1) की धारा 52 की उपधारा (2) के खंड (ज) और (थ) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, विधिक मापविज्ञान (पैक में रखी वस्तुएं) नियम, 2011 का और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात् :-

1. संक्षिप्त नाम और प्रारंभ - (1) इन नियमों का संक्षिप्त नाम विधिक मापविज्ञान (पैक में रखी वस्तुएं) (द्वितीय) संशोधन नियम, 2025 है।

(2) वे राजपत्र में उनके प्रकाशन की तारीख को लागू होंगे।

2. विधिक माप विज्ञान (पैक में रखी वस्तुएं) नियम, 2011 (जिसे इसमें इसके पश्चात् मूल नियम कहा गया है) में, नियम 6 के, उप-नियम (10) में, निम्नलिखित परंतुक अंतः स्थापित किया जाएगा, अर्थात्: -

"परंतु यह कि आयातित उत्पादों को बेचने वाली प्रत्येक ई-कॉमर्स इकाई अपने उत्पाद सूची के साथ मूल देश के लिए एक खोजी और सॉर्टेबल फिल्टर प्रदान करेगी।"
